Dear Mr. Sawyer:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

- 1. Make the following changes to your label:
- As you are aware, on October 1, 1996 the Agency required label changes for a) carbaryl end-use products labeled for residential (non-agricultural) use. According to this letter you must add the following language to your label.
  - 1) Add the following user safety requirements outlined by a box:

# **USER SAFETY REQUIREMENTS**

Wear long-sleeved shirt, long pants, shoes plus socks and household latex or rubber gloves when applying this product.

Change clothing as soon as possible after use.

Wash the outside of gloves before removing. As with any pesticide product, wash hands thoroughly immediately after handling and before eating, smoking or using the toilet.

available. Dust lightly to cover both upper and lower leaf surfaces with a thin, even film of dust. Apply when air is calm to avoid drift and contact with eyes and skin. Start applying at the farthest corner of the treatment area and work backward to avoid contact with dusted surfaces. Allow dust to settle in treated areas before reentering. For plants above chest height, consider using a liquid carbaryl product. Do not repeat application more than once a week."

- 3) To the Directions for Use on DOGS AND CATS, add: "Use product only outside or in as well-ventilated area. Wearing household latex or rubber gloves, dust entire animal, avoiding pet's eyes, nose, mouth and genital areas. Rub or brush pet's hair to work dust down to the skin. This product should not be applied by children. Do not use on pregnant dogs. Do not use on kittens or puppies under 12 weeks of age. Dust bedding and doghouse using a shaker can or other dust applicator."
- 2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

Our files have been updated to change the name of this product from Good-Way 5% Sevin® Dust to Riverdale 5% Sevin® Dust.

A stamped copy of the labeling is enclosed for your records.

Apply Riverdale 5% Sevin Dust when insects or their damage appear. Make applications in the morning or evening when it is cool. Treat upper and lower surface of all foliage for complete coverage. Repeat as necessary, generally at 7 day intervals. For best results, apply with a dust gun. Do not apply in excess.

# SMALL PRUIT INSECT CONTROL

GRAPES: To control grape berry moth, Japanese heetles, June beetles, red-banded leaf roller, grape leaf folder, grape leafhopper, and grape leaf skeletonizer. Apply just before first brood leaf folder larvae emerge from rolls and as needed for leafnoppers. (Treat upper and tower surface of all foliage for complete coverage.) Limitation 7 days before harvest.

STRAWBERRIES: To control meadow spittlebug, strawberry leaf roller and strawberry weevil. (Treat upper and lower surface of all foliage for complete coverage.) Limitation 1 day before harvest.

BLACKBERRYES, BOYSENBERRIES, DEWBERRIES, LOGANBERRIES AND RASPBERRIES: To control Japanese beetles, leaf rollers, leafhoppers and raspberry aphics. Treat upper and lower surface of all foliage for complete coverage. Limitation 7 days before harvest.

#### PRT USE

ON DOGS AND CATS: For ticks and fleas dust liberally over the entire animal, avoiding eyes, and rub thoroughly into the skin. Comb out dead ticks a few hours after treatment. Repeat at weekly intervals if needed. Do not treat kittens and puppies less than 6 weeks of age. Do not use on pregnant dogs.

IN AND AROUND DOG AND CAT QUARTERS: For ticks and fleas, dust liberally in and around sleeping quarters, kennels, and dog houses by means of a shaker can, hand or dust gun.
