WHEN TO APPLY: For best results apply when weeds are young and actively growing in Spring or early Fall. Apply when grass is moist (after a rain, sprinkling or dew). For most effective broadleaf weed killing action, avoid unnecessary disturbances, including watering, of treated areas for 48 hours after application. Watering will wash off weed killing material. Do not apply if rainfall is expected within 48 hours following treatment. Avoid contact with desirable shrubs, plants, vegetables, or flowers. Possible retreatment in approximately 30 days may be necessary if lawn is heavily overrun with weeds or if adverse low moisture conditions prevail and weeds are in a state of poor growth.
