Riverdale Tri-Power Jet-Spray Weed Killer
EPA Registration No. 228-284
Your Application Dated April 27, 1995

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided you make the following change:

- 1. You must reinstate the protective clothing statement, "Wear face shield or goggles, long pants, long-sleeved shirt, shoes and gloves when applying this product.", as on the previously accepted label (dated August 5, 1994).

The Agency has allowed registrants to delete the protective clothing and re-entry statements from labels of other products containing MCPA and MCPP when toxicity data indicate that these precautionary statements are unnecessary. However, the primary eye and dermal irritation studies that are required to make this determination for the subject product are still under review at the Agency. Until review of these studies is completed, the protective clothing statement must remain on the label to ensure adequate protection of users.

Based on preliminary review of the submitted toxicity studies and the nature of the product (spot weed treatment), we have concluded that the re-entry statement may be deleted at this time, as you requested.

A stamped copy is enclosed for your records. Please submit (one) final printed copy for the above mentioned label before releasing the product for shipment.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

USE PRECAUTIONS

Do not use this product for controlling weeds in flower or vegetable beds or around shrubs or ornamental plantings. Do not spray roots of desirable trees and plants. Do not spray on Dichondra, Lippia, nor on grasses where desirable Clovers are present. Do not apply to newly seeded grasses until they have been mowed 3 times. Do not cut grass 1 to 2 days before and after application. Do not reseed for 3 to 4 weeks after use. If lawn needs watering, water thoroughly before application. Do not water for 48 hours after application. Watering will wash off weed killing material. Do not apply if rainfall is expected within 48 hours. Avoid fine mists. Spray when air is calm to avoid spray drift that might injure desirable ornamental plants. Do not apply when temperature exceeds 90°F. Shake well before using.

This product contains a foam which marks the spot where the weed killer has been applied.

DIRECTIONS

1. Shake can just before using and occasionally during use.
2. Invert can, hold at arm's length, and point can at weed as you press button. Do not press button when can is in upright position.
3. Stand close to weed (1 to 2 feet) with can aimed at weed and away from face.
4. Push down briefly on button. Spray to cover center of weed, do not over-spray. The spray's foaming action will make it easy for you to see coverage.
5. One application will kill most weeds listed. If certain tough weeds are not dead within 3 weeks, repeat application.

STORAGE AND DISPOSAL

STORAGE: Keep from freezing. To be stored in original container and placed in an area inaccessible to children. Do not store near heat or open flame.
PESTICIDE DISPOSAL: Product remaining in original container should be disposed of by securely wrapping original container in several layers of newspaper and discarding in trash.
CONTAINER DISPOSAL: Do not incinerate or puncture. Replace cap and discard container in trash.
