SUBJECT: Label Amendment Riverdale Tri-Power Jet-Spray Weed Killer EPA Registration No. 228-284 Your Application Dated April 27, 1995

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided you make the following change:

1. You must reinstate the protective clothing statement, "Wear face shield or goggles, long pants, long-sleeved shirt, shoes and gloves when applying this product.", as on the previously accepted label (dated August 5, 1994).

The Agency has allowed registrants to delete the protective clothing and re-entry statements from labels of other products containing MCPA and MCPP when toxicity data indicate that these precautionary statements are unnecessary. However, the primary eye and dermal irritation studies that are required to make this determination for the subject product are still under review at the Agency. Until review of these studies is completed, the protective clothing statement must remain on the label to ensure adequate protection of users.

Based on preliminary review of the submitted toxicity studies and the nature of the product (spot weed treatment), we have concluded that the re-entry statement may be deleted at this time, as you requested.

A stamped copy is enclosed for your records. Please submit (one) final printed copy for the above mentioned label before releasing the product for shipment.
