



## DIRECTIONS

- Shake can just before using and occasionally during use. 1.
- Invert can, hold at arm's length, and point can at weed as you press button. Do not 2. press button when can is in upright position.
- Stand close to weed (1 to 2 feet) with can aimed at weed and away from face. 3.
- Push down briefly on button. Spray to cover center of weed, do not over-spray. The spray's foaming action will make it easy for you to see coverage. 4.
- One application will kill most weeds listed. If certain tough weeds are not dead 5. within 3 weeks, repeat application.
