
The label amendment referred to above, submitted in accordance with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

On the "Commercial" and "Residential" labelings:

1. Under the "Hazards to Humans and Domestic Animals" section of the labeling, revise the second sentence in this section to read: "Avoid contact with skin, eyes or clothing during and after application."
2. Under the "User Safety Recommendations" add the following statement: "Wash the outside of gloves before removing."
3. Add the following "Skin Sensitizer Statement": "This product may cause skin sensitization reactions in some people."

A stamped copy is enclosed for your records. Please submit one (1) copy of your final printed labeling before you release the product for shipment. This amended labeling supersedes all previously accepted ones. Please note, the Agency is unable to reregister this product because the other two active ingredients, MCPA and Dicamba are behind Triclopyr in the product reregistration process.
