Dear Mr. Meindl:

We have reviewed the data submitted in support of an alternate formulation and find it acceptable as a change in formulation not an alternate formulation. Since the toxicity profile has changed due to the new acute toxicity studies the confidential statement of formula dated June 8, 2006 has been changed to the basic formulation and is now the formula of record and replaces all previously accepted CSF's.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Please revise the Precautionary Statements to read as follows:

"Causes substantial but temporary eye injury. Harmful if absorbed through skin, inhaled or swallowed. Do not get in eyes or on clothing. Avoid contact with skin. Wear protective eyewear (goggles, face shield, or safety glasses). Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse." 2. Please submit an one year storage stability study for the proposed product along with a corrosion characteristics study. We recommend that observation be made at 0, 3, 6, 9 and 12 months intervals in the storage stability study.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.
