FOR USE IN MANUFACTURING ONLY

This material requires further mixing before use. For formulation into end use products for the following uses: non-crop indoors and outdoors, herbs, and lawns.

STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in original containers only. Store in a dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly. **DO NOT** put concentrate or dilute material into food or drink containers. **DO NOT** contaminate other pesticides, fertilizers, water, food or feed by storage or disposal.

Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

[Refillable containers]

CONTAINER HANDLING [DISPOSAL]: Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller.
