The active ingredient in this product has sufficient residual activity so that applications can be made preceding the egg laying activity of the target pests. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pests, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

It is a systemic product and will be translocated upward into the plant system from root uptake.
