This product can be used for the control of soil inhabiting pests of turfgrass, such as Northern & Southern masked chafers, Cyclocephala borealis, C. immaculata, and/or C. lurida; Asiatic garden beetle, Maladera castanea; European chafer, Rhizotroqus majalis; Green June Beetle, Cotinis nitida; May or June beetles, Phyllophaga spp.; Japanese beetle, Popillia japonica; Oriental beetle, Anomala orientalis; Billbugs, Spherophorus spp.; Annual bluegrass weevil, Hyperodes spp.; Black turfgrass ataenius, Ataenius spretulus; Aphodius spp.; European Crane Fly, Tipula paludosa, and Mole crickets, Scapteriscus spp. This product can also be used for the suppression of cutworms and chinchbugs in turfgrass areas. This product can be used as directed on turfgrass in sites such as home lawns, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, cemeteries, parks, playgrounds, and athletic fields. This product cannot be used on commercial sod farms.

The active ingredient in this product has sufficient residual activity so that applications can be made preceding the egg laying activity of the target pests. High levels of control can be achieved when applications are made preceding or during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch. Do not apply when turf is water saturated. The treated area must be in such a condition that rainfall or irrigation will penetrate vertically into the soil profile. Applications cannot exceed a total of 80 lb (0.4 lb of active ingredient) per acre per year.

APPLICATION TO ORNAMENTALS

This product can be used as a broadcast application on ornamentals in commercial and residential landscapes, as well as on landscaped areas of golf courses and other recreational areas. Application should be made prior to anticipated pest infestation to maximize control. Rainfall, irrigation and mechanical incorporation after application will also aid in maximizing control.

Applications of this product cannot exceed a total of 80 lb (0.4 lb of active ingredient) per acre per year.

NOTE: Not for use in commercial greenhouses, nurseries, on sod farms or on grass grown for seed. For use on plants intended for aesthetic purposes or climatic modification and being grown in interior plantscapes, ornamental gardens or parks, or on golf courses or lawns and grounds.
