4. Make the following label change:

- a. Under "User Safety Recommendations" add "If pesticide gets on skin, wash immediately with soap and water." (to the second group of statements) and add "Wash the outside of gloves before removing." (to the last set of statements).
- b. The Spray Drift language must be added to the label stating the following: "Spray Drift Management

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, relative humidity) and method of application (e.g., ground, aerial, airblast, chemigation) can influence pesticide drift. The applicator must evaluate all factors and make appropriate adjustments when applying this product.

Droplet Size

When applying sprays that contain 2,4-D as the sole active ingredient, or when applying sprays that contain 2,4-D mixed with active ingredients that require a Coarse of coarser spray, apply only as a Coarse or coarser spray (ASAE standard 572) or a volume mean diameter of 385 microns or greater for atomizer nozzles.

When applying sprays that contain 2,4-D mixed with other active ingredients that require a Medium or more fine spray, apply only as a Medium or coarser spray (ASAE standard 572) or a volume mean diameter of 300 microns or greater for spinning atomizer nozzles.

Wind Speed

Do not apply at wind speeds greater than 15 mph. Only apply this product if the wind direction favors on-target deposition and there are not sensitive areas (including, but not limited to, residential areas, bodies of water, known habitat for nontarget species, nontarget crops) within 250 feet downwind. If applying a Medium spray, leave one swath unsprayed at the downwind edge of the treated field.

Temperature Inversions

If applying at wind speeds less than 3 mph, the applicator must determine if: a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

Susceptible Plants

Do not apply under circumstances where spray drift may occur to food, forage, or other planting that might be damaged or crops thereof rendered unfit for sale, use or consumption. Susceptible crops include, but are not limited to, cotton, okra, flowers, grapes (in growing stage), fruit trees (foliage), soybeans (vegetative stage), ornamentals, sunflowers, tomatoes, beans, and other vegetables, or tobacco. Small amounts of spray drift that might not be visible may injure susceptible broadleaf plants.

Other State and Local Requirements

Applicators must follow all state and local pesticide drift requirements regarding application of 2,4-D herbicides. When states have more stringent regulations, they must be observed.

Equipment

All aerial and ground application equipment must be properly maintained and calibrated using appropriate carriers or surrogates

Additional requirements for aerial applications:

The boom length must not exceed 75% of the wingspan or 90% of the rotor blade diameter."

AGRICULTURAL USE REQUIREMENTS

Do not allow spray mist to contact these plants. Do not spray on buffalograss, carpetgrass, dichondra, nor on grasses where desirable clovers are present. Avoid fine mists. Use a lawn type sprayer with coarse spray as wind drift is less likely. Do not spray exposed roots of desirable plants. Use the higher rate for hard-to-kill weeds. Do not exceed specified application dosages for any area. Apply to newly seeded lawns or turf after grasses are well established and have been mowed three times. Avoid broadcast applications when air temperature exceeds 90 degrees. When using small, spot treatment applications in temperature over 90 degrees, turf injury may occur.

For optimum results: (1) turf should not be moved for 1 to 2 days before and after application; (2) do not apply if rainfall is expected within 8 hours; nor should lawns be irrigated (watered) for 24 hours following application. Reseed no sooner than three to four weeks after application of this product.

This product can be mixed with some liquid fertilizers or liquid iron materials. Because liquid fertilizers and liquid iron differ in pH, free ammonia content, density, salt concentration, and percentage of water, a compatibility test is recommended prior to mixing in the application equipment. All regulations, either State or Federal, relating to the application of liquid fertilizers or liquid iron and this product must be strictly followed.

The maximum seasonal rate is 3.0 lbs ae/acre, excluding spot treatment. Maximum rate per application is 1.5 lbs ae/acre, limited to 2 applications per year.

SIMILAR NON-CROP AREAS

Roadsides (including aprons and guard rails), rights-of-way, and other similar non-crop areas: For the control of broadleaf weeds, mix 2.5 pints to 3.5 pints of this product in 50 to 300 gallons of water. This mixture will cover 43,560 square feet (1 acre). Thoroughly saturate all weeds with spray mixture. Apply when plants come into full leaf (spring) to the time plants begin to go dormant. Best results are obtained when weeds are young and actively growing. Do not cut weeds until herbicide has translocated throughout the plant causing root death. For small broadleaf weeds, use the lower rate. Heavy, dense stands require the higher rate with high water volume.

For control of woody plants, apply to both stems and foliage from the time foliage is completely matured until the plants start to go dormant. All leaves, stems and suckers must be completely wet to the ground line for effective control. Regrowth may be anticipated on the more resistant species. Add .75 gallon to 1.25 gallons of this product to 100 gallons of water using 200 to 600 gallons of spray mixture per 43,560 square feet (1 acre) depending upon the height and thickness of the brush. Mix thoroughly before spraying.

For post-emergence (annual and perennials weeds) use on non-cropland (such as fencerows, hedgerows, roadsides, ditches, rights-of-way, utility power lines, railroads, airports and industrial sites) the following application restrictions apply: The minimum days between application is 30. The maximum rate of application is 2.0 lbs ae/acre, limited to 2 applications per year.

Applications to non-cropland areas are not applicable to treatment of commercial timber or other plants being grown for sale or other commercial use, or for commercial seed production, or for research purposes.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Always store pesticides in a secured warehouse or storage building. This product should be stored in a cool, dry location. Do not store near seeds, fertilizers, insecticides or fungicides. Containers should be opened in well-ventilated area. Keep container tightly sealed when not in use. Do not stack cardboard cases more than two pallets high.
