Best results are obtained when weeds are young and actively growing. Do not cut weeds until herbicide has translocated throughout the plant causing root death. For small broadleaf weeds, use the lower rate. Heavy, dense stands require the higher rate with high water volume.

For control of woody plants, apply to both stems and foliage from the time foliage is completely matured until the plants start to go dormant. Limited to 2 applications per year. Maximum of 6 pints per broadcast application. For woody plant control, there is a limit of 1 application per year.
