HOW MUCH TO APPLY

Trees: 1 ounce per inch of distance around trunk. Shrubs: 3 ounces per foot of height.

Tree with one trunk

Measure distance (in inches) around tree trunk at chest height. A flexible tape measure is the recommended method [tool]. This is the number of ounces of this product to apply.

Tree with two or more trunks

Measure the distance (in inches) around each tree trunk and add together. Multiply this total by 0.75 to get the required number of ounces of this product to apply. Example: A tree has 4 trunks. They measure 20, 10, 5 and 5 [inches] or a total of 40 [inches]. 40 x 0.75 = 30 ounces.
