This product is for use on ornamental shrubs and small trees in outdoor landscapes and interior plantscapes. It is a systemic insecticide and will be taken up by the roots and translocated upward within the plant system. Therefore watering after application makes the product more available for uptake.

Systemic activity using this soil application treatment method can be delayed until the active ingredient is translocated throughout the plant. For this reason, applications work best when made prior to pest infestation or before pest populations become severe.

#### WHERE TO APPLY

Shrubs and small trees in outdoor landscapes and interior plantscapes.

#### **USE RATE**

Select rate according to height of shrub or tree: Up to 4 ft. – use 1/8 to 1/4 cup; 4 to 8 ft. – use 1/4 to 1/2 cup. Use high rate for initial treatment and lower rates for re-applications, if needed. Not recommended for shrubs or trees greater than 8 feet tall. Instead use soil applications of other products approved for use on shrubs and trees.

#### HOW AND WHEN TO APPLY

Spread appropriate rate evenly around the base of plant under foliage, whenever pests are seen or found. Re-apply as needed based on pest re-infestation or at 4 to 8 week intervals. Apply early before pest populations become severe. Irrigation or rainfall should occur shortly after application. Pull back mulch and weed barrier before application. Avoid application to frozen or water-logged areas, as this may decrease the product's effectiveness.

Note: 1 level cup is approximately 6 ounces of this product.

#### ANT MANAGEMENT

Use this product to control aphids and other sucking pests on ornamentals to limit the honey dew available as a food source for ant populations. Applications can then be supplemented with residual sprays, bait placements or other ant control tactics to further reduce pest populations.

#### RESTRICTIONS

Do not apply near fish pools, ponds, streams or lakes. Treated areas may be replanted with any crop for which a tolerance exists for the active ingredient. For other crops, a 12-month plant back interval should be observed.
