2. Update the **Precautionary Statement** with the language following language:

Causes moderate eye irritation. Avoid contact with eyes or clothing. [Wear protective eyewear.] Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Wear long-sleeved shirts, long pants, socks, shoes and chemical resistant gloves.

- 3. Make the following changes on page 3 using more definitive language as is now required by the Agency:
 - Remove General from the heading "General Information". An example of more definitive language would be "Information Specific to this Product." You may chose to select another heading using definitive language.
 - In the first sentence of the last paragraph delete the word "should" and replace it with more definitive wording; an example would be using the word "must" or rewrite the statement as "Do not make applications when grassy areas are waterlogged…"
- 4. On pages 4 and 5 move the word "Recommended" from each of the headings. Under the heading "Restrictions", on page 5, remove or change the word "should" in the last sentence to the word "must" or chose other definitive language such as observe a 12-month plant back interval or a 12 month plant back interval much be observed."
- 5. You must generate studies for the guidelines 830.6314 (oxidation-reduction), 830.6315 (flammability), 830.6316 (explodability), and a one year Storage Stability study (830.6317) and Corrosion Characteristics study (830.6320) and submit them to the Agency. The Agency recommends that observations be made at 0, 3, 6, 9, and 12 months for guidelines 830.6317 and 830.6320.
- 6. Submit two copies of your final printed label before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitute acceptance of these conditions.

GENERAL INFORMATION

This product is for insect control on ornamental plants in nurseries, greenhouses and interior plantscapes. This product is a systemic product and will be translocated upward within the plant. To assure optimum effectiveness, the product must be placed by incorporation where the roots of the plant can absorb the active ingredient. Irrigate moderately but thoroughly after application, allowing no leaching and runout from containers for at least three irrigations or 10 days whichever is longer.

Resistance: Some insects are known to develop resistance to Insecticides after repeated use. As with any insecticide, the use of this product should conform to resistance management strategies established for the use area. Consult your Cooperative Extension Service for resistance management strategies and recommended pest management practices for your area.

Incorporation: Incorporation of this product can be achieved by cultivation, irrigation, rainfall, mechanical placement or by using mechanical soil or media mixing equipment.

Woody Perennials: Onset of protection is slower than in herbaceous species. A delay of 2 or more weeks should be expected. Longer delays may be expected with larger plants. Application should therefore be made in advance of expected insect activity.

Bark Media: Media with 30% or more bark content when treated with this product may confer a shorter period of protection.

APPLICATION TO GRASSY AREAS IN NURSERIES

This product can be used for the control of soil inhabiting pests of grassy areas or nurseries, such as Northern and Southern masked chafers, Cyclocephala borealis, C. immaculata, and/or C. lurida; Asiatic garden beetle, Maladera castanea; European chafer, Rhizotroqus majalis; Green June beetle, Cotinis nitida; May or June beetle, Phyllophaga spp.; Japanese beetle, Popillia japonica; Oriental beetle, Anomal orientalis; Billbugs, Spherophorus spp.; Annual blugrass weevil, Hyperodes spp.; Black turfgrass ataenius, Ataenius spretulus and Aphodius spp. and mole crickets, Scapteriscus spp. This product can also be used for suppression of cutworms and chinchbugs. This product can be used as directed on nursery grass in sites such as under or around field or container grown plants, on roadways or other grassy areas in or around nurseries.

This product has sufficient residual activity so that applications can be made in early spring through the egg laying activity of the target pests. High levels of control can be achieved from early spring or when applications are made during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pests, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Applications should not be made when grassy areas are waterlogged or the soil is saturated with water. Adequate distribution of the active ingredient cannot be achieved when these conditions exist. The treated grassy area must be in such a condition that the rainfall or irrigation will penetrate vertically in the soil profile. Application cannot exceed a total of 8 pounds of product (0.4 lb. of active ingredient) per acre per year.

For systemic insect control on greenhouse, interior plantscapes and nursery ornamentals grown in flats, benches, beds and container.

RESTRICTIONS

Do not graze treated areas or use clippings from treated areas for feed or forage.

Do not apply to soils which are water-logged, or saturated. This condition will not allow the penetration of water into the root zone of the plants.

For outdoor omamentals grown in beds or turf, applications of this product cannot exceed a total of 8 pounds per acre per year.

On plants with a production cycle of less than one year, application is not to exceed a frequency of more than once each 16 weeks for a particular plant. On stock plants and woody crops with a production cycle of greater than one year, application may not exceed once a year.

Food Crops: Treated areas may be replanted with any crop specified on an imidacloprid label, or with any crop far which a tolerance exists for the active ingredient.

For crops not listed on any imidacloprid label, or for crops for which no tolerances for the active ingredient have been established, a 12 month plant-back interval should be observed.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
