Apply this product uniformly to golf course turfgrass, road medians and industrial plant sites using any hand or power operated gravity or rotary type spreader designed for application of granular materials. Treat when insects first appear using this product at the rate of 200 pounds per acre. Apply ½ the required amount of product in one direction; then apply the balance at a right angle to the original application to aid in uniform distribution of the product.
