You continue to be subject to existing conditions on your registration and any deadlines connected with them.

Use this product to accelerate fruit maturation or to facilitate uniform fruit ripening of greenhouse tomatoes.

Crop Situation	Product Application Rate	Application Instructions
Late-season	1.25 to 5 pints/acre (0.5 to 1.8 fl oz/1,000 ft ²)	Foliar Application Spray the solution on the plant foliage and fruit. Apply when fruit has reached a marketable size.
Late-season	2 to 5 pints/acre (0.75 to 1.8 fl oz/1,000 ft ²)	Stem Application Mix with water in a 1:6 ratio Apply with a brush or sponge directly to the stem in stripes 3 – 6 inches long just below the fruit. Apply when fruit has reached a marketable size. NOTE: Avoid application to fruit.
Directional application used to aid in uniform maturation of cluster tomatoes or individual fruit with irregular maturing	1.5 – 3.5 ml/L of spray solution OR 1 – 2.5 teaspoons per gallon of spray solution Buffer to pH 6.0	Apply directly to fruit to aid in uniform maturation. Use a handheld sprayer or spray applicator directed specifically to individual fruit. NOTE: To avoid damage to the plant, do not spray entire plant or foliage.

RESTRICTIONS:

- Pre-Harvest Interval (PHI): 48 hours
- Do not apply more than 5 pints of product per acre (1.8 fl oz/1,000 ft²) per year.
