This product is for insect control in grassy areas in nurseries and on ornamental and vegetable plants (intended for resale only) in nurseries, greenhouses and interior plantscapes. This product is a systemic product and will be translocated upward within the plant. Apply this product to plant foliage when directed or to the soil where the roots of the plant can absorb the active ingredient. Irrigate modestly but thoroughly after soil applications, allowing no runoff from treated area and no leaching and runout from containers for at least three irrigations or 10 days whichever is longer.

**Resistance:** Some insects are known to develop resistance to Insecticides after repeated use. As with any insecticide, the use of this product should conform to resistance management strategies established for the use area. Consult your Cooperative Extension Service for resistance management strategies and recommended pest management practices for your area.

**Incorporation:** Incorporation of this product can be achieved by one of the following methods; cultivation, irrigation, rainfall, mechanical placement, soil injection, drenching and broadcast sprays.

**Woody Perennials:** Onset of protection is slower than in herbaceous species. A delay of 2 or more weeks should be expected. Longer delays may be expected with larger plants. Application should therefore be made in advance of expected insect activity.

**Bark Media:** Media with 30% or more bark content when treated with this product may confer a shorter period of protection.

#### **APPLICATION THROUGH IRRIGATION SYSTEMS (CHEMIGATION)**

Apply this product at rates specified on this label either alone or in tank mixture with other pesticides and chemicals registered for application through irrigation systems. The normal dilution ratio is 1:10 to 1:200, depending on the system. Always meter the product into the irrigation water during the first part of the irrigation cycle. Mix the product separately prior to injection. Agitate as necessary if the mixture is allowed to stand more than 24 hours.

- DO NOT connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.

#### MIXING INSTRUCTIONS

Within each foil pouch is a clear, water-soluble inner packet containing this product. To prepare the mixture, remove the outer foil pouch and drop the required number of unopened clear water soluble packets, as determined under "Drench and Irrigation Applications", into the spray tank while filling with water to the desired level. Operate the agitator while mixing. Depending on the amount of agitation and the water temperature, the packets should be completely dissolved within a few minutes of being added to the water, with cooler water temperatures increasing the time needed for the inner packet to dissolve completely.

#### **Mixing Precautions:**

Apply this product in sufficient water to provide adequate distribution in the treated area. The use of accurately calibrated equipment normally used for soil application of insecticides is required. Use equipment that will produce a uniform, coarse droplet spray, using a low pressure setting to eliminate off-target drift. Check calibration periodically to ensure that equipment is working properly.

#### Remarks

For control of grubs, billbugs, European crane fly and annual bluegrass weevil, make application prior to egg hatch of the target pest.

For control of mole crickets make application prior to or during the peak egg hatch period. When adults or large nymphs are present and actively tunneling, accompany this product with a remedial insecticide.
