The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. The next label printing of this product must use this labeling unless subsequent changes have been approved. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. 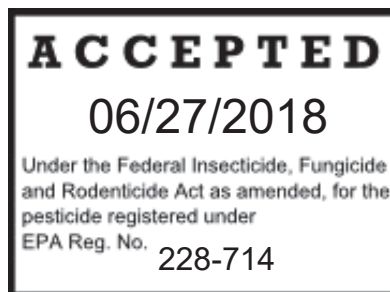

3. Insert hose connector into (color) spout on cap until clicks into place.
4. Flip up spout. Turn sprayer nozzle to open
5. Spray.]

[[Quick Connect Sprayer] [Trigger] [Use Directions:]]

1. Remove sprayer. Pull cord **ALL THE WAY OUT**.
2. Insert (color) plug into spout [on cap] until clicks into place.
3. Flip up spout.
4. Open nozzle at the end of sprayer
5. Spray.]

HOW TO USE:

Turn sprayer nozzle to open. Adjust spray nozzle to give a coarse spray. Hold spray nozzle [[12] [twelve] or more [inches] ["]]] [[1] [one] foot ['] or more] from [weeds] [vegetation] [plants] [soil] to be treated. Allow spray to soak into ground, avoiding runoff to nearly desirable [vegetation] [plants].

For cracks in [driveways], [sidewalks], [patios] and between bricks and paving stones:

1. Detach (color) wand and pull plug and tubing from bottom of wand. Insert plug firmly into "T-Handle" until it clicks into place. **ONCE CONNECTED, PLUS CANNOT BE REMOVED WITHOUT DAMAGING "T-Handle".**
2. Slide white strip on cap, then grab "T-Handle" and pull all the way up. **PULL UP, NO PUMPING NEEDED.**
3. Point wand at area to be treated and push button to begin spraying. Twist nozzle at end of wand to adjust spray pattern. Coarse spray minimizes drift.
4. Pull "T-Handle" again as needed to continue spraying. **PULL UP, NO PUMPING NEEDED.** When finished, push "T-Handle" gently down to cap and follow instructions in **STORAGE AND DISPOSAL.**

HOW TO USE:

Adjust spray nozzle and wand to give a coarse spray. Pull on the handle. **DO NOT PUMP.** Follow instructions [above] [provided]. Point wand at [area] [weeds] [vegetation] [plants] [soil] to be treated and push button to begin spraying. Allow spray to soak into ground, avoiding runoff to nearly desirable [vegetation] [plants].

For cracks in [driveways], [sidewalks], [patios] and between bricks and paving stones:

- Point Sprayer away from body.
- Grasp sprayer by handle.
- Slowly pull ring at the bottom of sprayer handle until it stops and hold for [2] [two] seconds to ready the sprayer.
- Press and hold button on sprayer to begin spraying.
- Pull ring at sprayer bottom again as needed to continue spraying.

- [Tilt bottle slightly to adjust product flow.]
- Allow spray to soak into ground, avoiding runoff to nearly desirable [vegetation] [plants].

HOW TO USE:

Follow instructions [above] [provided]. Point sprayer away from body and at [area] [weeds] [vegetation] [plants] [soil] to be treated.

For cracks in [driveways], [sidewalks], [patios] and between bricks and paving stones:
Spray [weeds] [vegetation] [plants] [soil] in the crack until completely wet.

1. Remove sprayer from side holder. [Unwrap the tubing] [Gently pull tubing out]. [Graphic depiction]
2. Remove seal from top of cap. Unplug cap. [Graphic depiction]
3. Securely snap the [green] plug into hole on cap. [Graphic depiction]
4. Remove plastic tab near [top] [bottom] of sprayer to activate batteries. [Graphic depiction]
5. Twist nozzle to adjust spray from CLOSE to SPRAY or STREAM. [Graphic depiction]
6. [When priming the sprayer, hold sprayer level to the ground. Sprayer may not prime if it is held at an angle. Once primed, it will spray in any direction]

[(OPTION 5 B) - [USE DIRECTIONS]

[OPERATING INSTRUCTIONS FOR AccuShot Sprayer] (Option B)

1. Remove cap and replace with reusable AccuShot Sprayer. Make sure sprayer cap is tightly closed before use
2. Twist nozzle to adjust spray from CLOSE to SPRAY or STREAM. [Graphic depiction]
3. [When priming the sprayer, hold sprayer level to the ground. Sprayer may not prime if it is held at an angle. Once primed, it will spray in any direction. (Graphical representation.)]]

[(OPTION 5) - [How to Use the AccuShot Sprayer]

- Aim toward target [site] [area to be treated], and away from people and pets.
- [To improve accuracy, use slider to extend wand.][Use slider to extend wand and to improve accuracy.]
- Press the trigger to spray.
- Release the trigger to stop spray.]

[After use:

1. Twist nozzle completely to CLOSE position.
2. Secure sprayer [upright] [tip down] in [holster] [holder].
3. **Failure to adjust nozzle completely to CLOSE position and properly secure sprayer in [holster] [holder] may result in leakage and damage to property or injury to people or animals.]**

[Keep reusable AccuShot sprayer for use with 228-714]

[To replace batteries:

1. [Slide battery compartment door to unlatch and open.] [Push release button near nozzle and lift up on battery hatch.] [Use screwdriver to open battery compartment]
2. Remove used batteries and insert [four] [two] new AA batteries **in correct positions** as marked per diagram inside of battery compartment. Never insert the positive end where the negative end belongs and vice versa. **Always** use a complete set of new batteries of the same type when replacing batteries. **Never** mix alkaline, carbon-zinc or rechargeable batteries.

In soils with heavy clay, weed control may exceed [1] [one] year. Re-treatment every [6] [six] to [8] [eight] months may be necessary in areas of heavy rainfall.
