Mix only with water. Use clean dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Storage or use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic matter, or other chemicals may start a chemical reaction, with generation of heat, liberation of hazardous gases, and possible generation of explosion. In case of contamination or decomposition, do not reseal container. If possible, isolate container in open air or well ventilated area. Flood with large volumes of water, if necessary.

STORAGE AND DISPOSAL: Keep product in closed container when not in use. Store in dry, well-ventilated area away from heat and flame. Do not contaminate water, food or storage or disposal.
