

CDB CLEARON FABRIC AND DIAPER SANITIZER is recommended for stain removal and reduction of ammonia causing bacteria in institutional & commercial laundering of fabrics and diapers.

### DIRECTIONS FOR USE

Wet fabrics or diapers should be spin dried before the sanitizer is applied. Four (4) oz. of CDB CLEARON FABRIC AND DIAPER SANITIZER should be added for each 16 gallon wash load. Run this solution in the pre-wash, followed by the regular wash cycle with a good detergent. The above application gives 200 ppm available chlorine in the pre-wash cycle.

The sanitizing solution should be used promptly after mixing. If the solution is allowed to stand or is reused and tests show the level of chlorine has not been maintained, additional CDB CLEARON FABRIC AND DIAPER SANITIZER should be added, to give 200 ppm available chlorine in the pre-wash cycle.
