

Also repellent to pheasants. Where Seedling Blight, Damp-Off or Seed Decay normally occurs, combine with a full dosage of protective fungicide. ISOTOX Seed Treater (F) may be used on corn seed previously treated with a protective fungicide.

DIRECTIONS

APPLY IN PLANTER BOX USING DESIGNATED AMOUNT PER 100 LBS. SEED. MEASURING CUP ENCLOSED - One level cup contains approximately one ounce of product.

Baby Bush Limas - 2 ozs.

Bush, Snap and all other except Limas - 2 ozs.
