In addition to rapid initial kill, ORTHO Ant, Roach & Spider Spray stays on treated surfaces and provides residual insect killing power after the spray deposit has dried.

HOW TO USE: ORTHO Ant, Roach & Spider Spray delivers a spray stream allowing the user to direct the spray to a distance of 3-4 feet. Cracks, crevices, and hard-to-reach locations can be reached without bending, crawling, or climbing. Spray infested surfaces until wet, moving the spray stream rapidly to prevent excessive wetting of surfaces, and waste of material. Point spray away from people, plants and pets.

RESTRICTIONS: Do not apply to rugs, carpets, draperies, wall paper, or similar materials that may be stained. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings.

FLAMMABLE: Contents under pressure. Do not puncture. Exposure to high temperatures may cause bursting. Keep at room temperature—away from direct sunlight, radiators, stoves, hot water or other heat. Never throw container into fire or incinerator.

DIRECTIONS FOR USE

ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS: INDOORS: Spray into cracks, crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Spray ant trails and places where ants enter premises. Repeat as needed. Residual activity against roaches lasts up to two weeks.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

ANTS, CRICKETS, EARWIGS, SOWBUGS, and BROWN DOGTICKS—OUTDOORS: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation.

KEEP OUT OF REACH OF CHILDREN

CAUTION: May be harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes, or clothing should also be avoided. Do not allow children to contact treated surface until surfaces are completely dry. Wash thoroughly with soap and warm water after handling. Avoid contamination of food, utensils, and food preparation areas. Do not use in commercial food preparation areas or in edible products areas of food processing plants. Remove pets and cover aquarium in areas to be treated. If poisoning occurs, obtain prompt medical aid. To Physician—Atropine sulfate is antidotal.
