In addition to rapid initial kill, ORTHO Ant, Roach & Spider Spray stays on treated surfaces and provides residual insect killing power after the spray deposit has dried.

HOW TO USE: Spray infested surfaces until wet, moving the spray stream rapidly to prevent excessive wetting of surfaces, and waste of material. Point spray away from people, plants and pets.

RESTRICTIONS: Do not apply to rugs, carpets, asphalt tile, draperies, wallpaper or similar materials that may be stained. Avoid excessive wetting of plastic and rubber surfaces such as tiles and floor coverings.

DIRECTIONS FOR USE

ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, INDOORS—Spray into cracks, crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Spray ant trails and places where ants enter premises. Repeat as needed. Fresh food activity against roaches lasts up to two weeks.

BROWN DOG TICKS—Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

ANTS, CRICKETS, EARWIGS, SOWBUGS, and BROWN DOG TICKS—OUTDOORS—Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, porches, or other places where insects may enter. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation.

KEEP OUT OF REACH OF CHILDREN
