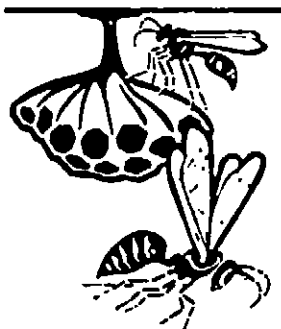

DIRECTIONS FOR USE

Most bees and wasps are beneficial; however, when their nests are built too close to windows, doorways, or children's play areas, they may be dangerous and should be killed. **FOR CONTROL OF WASPS AND HORNETS:** Apply after dark when all of the insects have returned to the nest. Remove protective cap. Hold container in upright position to spray. Aim valve opening at nest, hold at arm's length and depress button, soaking the entire nest with spray. Spray jet will reach nests up to 20 feet above ground. Repeat as necessary. Avoid spraying plant foliage as injury may occur. Do not use as a space spray. For outdoor use only. Avoid excessive wetting of asphalt, rubber and plastic materials.

OTHER USES - OUTDOORS ONLY: For Control of Clover Mites, Crickets, Earwigs, Fleas, Millipedes, Sawbugs, and Brown Bag Ticks. Spray infested areas thoroughly including outside surfaces of screen frames, doors, window frames, foundations, patios or other places where insects may enter or harbor. **FOR ANTS:** spray hills and runways. Repeat as necessary. Do not spray vegetation. Do not use as a space spray.

FOR SPIDERS - OUTDOORS ONLY: Spray directly on spiders and treat webs and tracking areas around porches, under eaves along foundations, similar outdoor areas. Repeat as necessary. Spray may cause injury to flowers and ornamentals. Before using on easily stained surfaces, test a small spot before giving full treatment.

Do not reuse empty container. Wrap container and put in trash collection.
