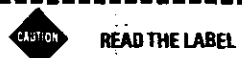
### DIRECTIONS

**TOBACCO (Flue-cured, Air-cured):** Budworm, Green Peach Aphid, Hornworm, Cabbage Looper, Flea Beetle— $\frac{1}{2}$  to 1 lb. (0.50 to 0.75 lb. active) per acre in 10 to 50 gals. of spray mix applied with conventional ground equipment. Apply  $\frac{3}{4}$  lb. per acre to control Green Peach Aphid, Flea Beetle and Hornworm. Apply 1 lb. per acre to control Budworm and Cabbage Looper. Apply on a 7 day schedule or as needed. Do not apply within 3 days of harvest. Do not re-enter sprayed areas until the spray deposit has dried.

**NOTE:** This product is sold by weight and package is full when packed, but due to fluffy nature this material is inclined to settle.

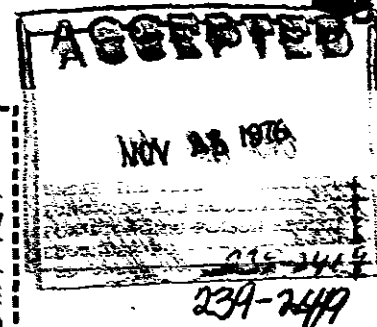
