

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS & DOMESTIC ANIMALS

CAUTION: Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs and domestic water supplies. Wash thoroughly after handling. **Note to Physicians:** Emergency Information - call (415) 233-3737. Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal. 2-PAM is also antidotal and may be used in conjunction with atropine but should not be used alone. **PHYSICAL OR CHEMICAL HAZARDS:** Do not use or store near heat or open flame. Do not store below 32°F.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ ENTIRE LABEL. USE STRICTLY IN ACCORDANCE WITH LABEL PRECAUTIONARY STATEMENTS AND DIRECTIONS.

For use in homes, apartments, attics, garages, basements and storage areas. Non-staining, non-damaging to carpets, rugs, floors and baseboards. Kills insects on contact and keeps on killing for weeks with residual action.

HOW TO USE—Shake before using. Fold back protective hinged tab at end of nozzle. Snap in place on sprayer top. Hold container about 12 inches from surface being sprayed. Spray until surfaces are slightly wet. Do not spray on plants. Wash dishes and food handling utensils with soap and water if accidentally sprayed. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish aquaria before spraying. Repeat treatment as needed.

SUGGESTION: To improve residual control of crawling pests such as fleas, roaches, spiders, silverfish, ants and crickets, use ORTHO Hi-Power Indoor Insect Fogger after treating surfaces with this product. The total release program will flush hiding insects out of hiding where they will be killed. Follow all precautions, directions and limitations on both product labels.

FLEAS, BROWN DOG TICKS—Remove soiled pet bedding and clean thoroughly or destroy. Spray sleeping quarters of pets, along baseboards, windows, door frames, cracks and crevices, carpets, rugs, floors where these pests may be found. Put fresh bedding in pet quarters after spray has dried.

DO NOT SPRAY ANIMALS. Pets should be treated with FLEA-B-GON Flea Killer (aerosol).

CARPET BEETLES—Thoroughly apply as a spot treatment spray along baseboards and edges of carpeting, under carpeting, rugs, and furniture, in closets and on shelving, or wherever these insects are seen or suspected.

ROACHES, ANTS, CLOVER MITES, CRICKETS, FIREBRATS, SILVERFISH AND SPIDERS (Including Black Widow Spiders and Scorpions)—Thoroughly apply under and behind sinks, stoves, refrigerators, cabinets, around plumbing, along baseboards, and other areas where insects hide including dark corners of rooms, cabinets, cracks and crevices in walls and floors. **ANTS:** Apply directly to ants and ant trails or wherever these pests may gain entrance.
