





**DIRECTIONS FOR USE**

**HOW TO USE:** Shake before using. Adjust spray nozzle to give a fine spray or a stream for crack and crevice treatment.

*For 1 pt. 8 fl oz. size:*

Hold container about 12 inches from surface being sprayed. Spray until slightly wet. Repeat treatment as needed.

Do not spray on plants. Wash dishes and food handling utensils with soap and water if accidentally sprayed. *[Child/Pet Icon]* Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish aquaria before spraying.

*For 1/2 gal and larger sizes:*

Hold container upright and spray until wet. Repeat treatment as needed.

Do not spray plants. Wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. *[Child / Pet Icon]* Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish aquaria before spraying. Do not use as a space spray.

**FLEAS, BROWN DOG TICKS**  
 Remove soiled pet bedding and clean thoroughly or destroy. Spray pet's sleeping quarters, along baseboards, windows, door frames, cracks and crevices, carpets, rugs, floors where these pests may be. Put fresh bedding in pet quarters after spray has dried.

**TO REFILL:** Use the 1 gallon size of ORTHO Home Pest Insect Control to fill this container. No dilution required.

**STORAGE AND DISPOSAL**


**STORAGE:** ~~*[For conventional trigger sprayer]*~~ To store, rotate nozzle to closed position. [For larger than 24 oz. sizes : Place sprayer nozzle under handle on container so the sprayer is not below level of contents of container to prevent leakage and siphoning from nozzle.] ~~*[For proprietary sprayer and bottle]*~~ Flip down spout to close. ~~*No need to disconnect trigger sprayer. Close nozzle on trigger sprayer. Snap sprayer back in place.*~~ Keep pesticide in original container. Do not put concentrate or dilute into food or drink containers. Avoid contamination of feed and foodstuffs. Store in a cool, dry place, preferably in a locked storage area. Do not store below 32°F.

**DISPOSAL:** [For products 1 gal. size and under: Do not reuse empty container.
