HOW TO USE: Shake before using. Fold back protective hinged tab exposing nozzle. Snap in place on sprayer top. Adjust spray nozzle to give a fine spray. Hold container about 12 inches from plant being sprayed. Spray until slightly wet.

KILLS: Aphids, Cabbage Looper, Flea Beetles, Leafhoppers, Stink Bugs, Twelve-Spotted Cucumber Beetles and Whiteflies.

PLANTS: African Violets, Gladiolus, Asters, Azaleas, Begonias, Camellias, Carnations, Chrysanthemums, Dahlias, Dogwood, Marigold and Roses.

STORAGE AND DISPOSAL

STORAGE: (For 24 OZ size) To store, rotate nozzle to closed position. For storage, reseal by replacing tab closure over spray nozzle. (For 1/2 GAL & 1 GAL size) After each use, rotate nozzle to closed position. Keep pesticide in original container. Do not put concentrate or dilute into food or drink containers. Avoid contamination of feed and foodstuffs. Store in a cool, dry place, preferably in a locked storage area. **IMPORTANT:** After each use, store sprayer nozzle under handle on container above liquid level of contents to prevent leakage and siphoning from nozzle.

DISPOSAL: PRODUCT—Partially filled bottle may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash. **CONTAINER**—Do not reuse empty bottle. Rinse thoroughly before discarding in trash.
