



Weeds in newly seeded lawns may be sprayed after lawn has been mowed 3 times.

[FOR 24 oz. size only] To Prepare Refill: Add 1 tablespoonful of WEED-B-GON Lawn Weed Killer, EPA Reg. No. 239-2342, to this empty container, then add 24 oz. (1-1/2 pints) tap water and use according to directions on this label.


