DIRECTIONS

Spot Treatment—Imported Fire Ants: To control imported fire ants in lawns and other recreational areas, apply ½ cup in a 3 ft. radius over and around each fire ant mound. Immediately after application, water in thoroughly. A minimum of 1 gallon of water should be applied to each mound area. Do not use more than 2 gallons of water. Apply water gently to avoid disturbing ants. Use of high pressure watering may disturb the ants and cause migration, thus reducing effectiveness of treatment. Treat new mounds as they appear. For best results, apply in the early morning or late evening hours.

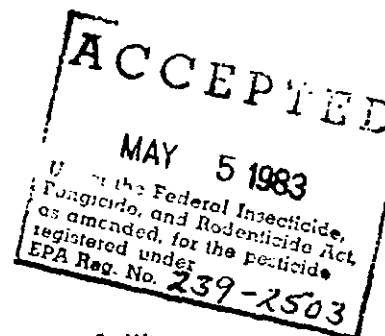
