

KLEENUP Grass & Weed Killer is formulated for "spot" application to individual weeds. The weed killer moves systemically through all parts of the plant. Visible effects usually occur within 1 week on most weeds with complete kill in 1 to 2 weeks.

HOW TO USE

Apply with hand trigger sprayer. Sprayer nozzle should be adjusted to allow a coarse spray or jet stream for applying to cover area occupied by unwanted weeds or grasses. Stand close to weed (1 to 2 feet) with spray nozzle aimed at weed and away from face. Spray to cover center of weed. Do not overspray. One application will kill most weeds listed. If certain tough weeds, i.e., Bermudagrass, Canada Thistle or Field Bindweed are not completely controlled within 2 weeks, repeat application. This product is a non-selective weed killer and will kill all vegetation contacted. Treated areas in lawns can be reseeded 7 days after application.

IMPORTANT: KLEENUP Grass & Weed Killer is a contact herbicide that will kill all green plant tissue. Be careful when treating weeds not to spray surrounding desirable grasses or nearby plants as they will also be killed. Also avoid spraying under conditions involving possible drift to desirable plants. Do not apply when rainfall is expected within 6 hours of application as weed control will be reduced. If spray accidentally contacts desirable foliage, wash off immediately with water.

STORAGE AND DISPOSAL

STORAGE: To store, rotate nozzle to closed position. Keep pesticide in original container. Do not put concentrate or dilute into food or drink containers. Avoid contamination of feed and foodstuffs. Store in a cool, dry place, preferably in a locked storage area. Keep from freezing.

1/2 & 1 GAL. size

STORAGE: Keep pesticide in original container. Do not put concentrate or dilute into food or drink containers. Avoid contamination of feed and foodstuffs. Store in a cool, dry place, preferably in a locked storage area. Keep from freezing. **IMPORTANT:** After each use, rotate nozzle to closed position. Store sprayer nozzle under handle of container above liquid level of contents to prevent leakage and siphoning from nozzle. **DISPOSAL: PRODUCT**—Partially filled jug may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash. **CONTAINER**—Do not reuse empty jug. Rinse thoroughly before discarding in trash.
