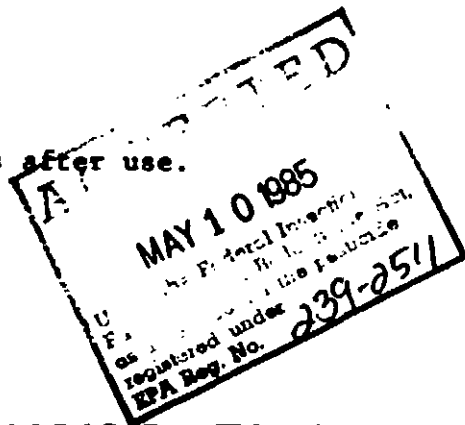

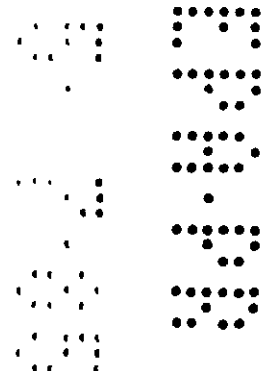

DIRECTIONS

3. Stand close to weeds, spray weed and away from yourself.
4. Push down briefly on button. Weed, do not over-spray. This makes it easy for you to treat.
5. One application will kill most tough weeds are not a problem.

NOTE: Be careful when using around desirable grasses. Grass can be tolerated. Also avoid use by flowers and other plants.

Do not use on Clover or fine or Carpetgrass mat.

- 1 Shake can just before using; if occasionally during use.
- 2 Invert can, hold at arm's length, and point can at weed as you press button. Do not press button when can is in upright position.
- 3 Stand close to weed (1 to 2 feet) with can aimed at weed and away from face.
- 4 Push down briefly on button. Spray to cover center of weed, do not over-spray. The spray's foaming action will make it easy for you to see coverage.
- 5 One application will kill most weeds listed. If certain tough weeds are not dead within 3 weeks, repeat application.

NOTE: Be careful when treating weeds not to spray surrounding desirable grasses unless temporary discoloration can be tolerated. Also avoid spraying or spattering of nearby flowers and other desirable plants.

Do not use on Clover or Dichondra. Bentgrass, St. Augustine or Carpetgrass may be injured by use of this product.
