DIRECTIONS

Point valve opening away from face and push button, holding container as upright as possible. Apply about 3 feet from walls, fabric and furniture. Do not remain in treated area and ventilate the area after treatment is completed. For applications into cracks and crevices, attach extension tube to spray actuator and spray directly into places suspected of harboring insects.


FLIES, MOSQUITOES, WASPS, GNATS: As a room spray to control these insects press valve and direct spray to all parts of room, especially the upper corners and other areas, filling the room with mist. Also spray areas where pests may tend to congregate, such as along walls, baseboards, cracks in woodwork, and other areas. Repeat as necessary. **ANTS, ROACHES, FLEAS, SPIDERS, EARWIGS, SAWBUGS, CENTIPEDES:** Spray directly on insects whenever possible and in areas where insects may be found, such as in carpets, under sinks, firewood piles, drainboards, cabinets, cracks and crevices on baseboards, pipes, around doorsills, window frames, screens, garbage cans, refuse areas in attics, behind shelving, bookcases, storage areas and other areas where pests may be found. Repeat as necessary.

STORAGE AND DISPOSAL

STORAGE: Store in a secure, preferably locked storage area away from heat or open flame.
DISPOSAL: PRODUCT—Unused product may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash. **CONTAINER**—Replace cap and discard container in trash. Do not incinerate or puncture.


