Subject: Application for Label Amendment for Ortho Indoor Insect Killer EPA Reg. No. 239-2512

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

Ingredient Statement. The second active ingredient should read as follows: [3-phenoxybenzyl-(1RS, 3RS; 1RS, 3SR)-2,2-dimethyl-3-(2-methylprop-1-enyl) cyclopropanecarboxylate. This would bring the label into accord with the Sumithrin registration standard.

Modify the petroleum distillate note to read as follows: "Contains petroleum distillate, xylene, or xylene range aromatic solvent."

Storage and Disposal Statement. The Container Disposal Statement is not optional for products intended for homeowner use. It should be modified to read as follows: "Securely wrap original container in several layers of newspaper and discard in trash."

**Precautionary Statements**. Move the following statements to the directions for use:

Avoid contamination of food and feedstuffs. Do not use in commercial food processing, preparation, storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Cover exposed food.
