

To Kill Cockroaches, Ants, **Cricket**s, and Spiders (including **Black Widow Spiders**): Contact as many insects as possible. Spray cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas, and wherever these pests hide. To kills ants, spray **directly** on ants, ant trails, and other areas of entry. Repeat as necessary.

To Kill Confused Flour Beetles, **Indian Meal Moth**, Sawtoothed Grain Beetles and Rice Weevils: Destroy **infested** package goods. Remove all other items from pantry. Spray the shelves. Place clean paper on the shelves after the spray has dried. Repeat as necessary.

To Kill Sowbugs, **Centipedes**, **Firebrats** and Spiders: Contact as many insects as possible with the spray. 
