Younger, actively growing seedling weeds are more easily killed than older, mature, well-established grassy weeds.</p> <p>Annual bluegrass (<i>Poa annua</i>), bahiagrass, barnyardgrass, bentgrass, Bermudagrass, centipedegrass, crabgrass, dallisgrass, downy brome, foxtails, goosegrass, johnsongrass, Kentucky bluegrass, nimblewill, orchardgrass, quackgrass, panicum, perennial ryegrass, sandbur, St. Augustinegrass and tall fescue.</p> <p>Note: This product does not control broadleaf weeds or sedges (nutgrass). Select an appropriate Weed-B-Gon® product.</p>
<p>WHEN TO APPLY</p>	<p>Anytime weeds are actively growing. Warm, sunny weather will accelerate systemic movement from leaves and stems down to the roots to give complete kill.
