2. Add the phrase, "EPA Registration No. 239-2621" to your label before you release the product for shipment.

3. Under precautionary statements, change the statement "...may be harmful if swallowed" to read "Harmful if swallowed." Also change "Avoid contact with skin", to read "Avoid contact with skin, eyes or clothing" and delete "Do not get in eyes or on clothing" since these two statements are redundant.

4. Under Statements of Practical Treatment, change the "If On Skin" statement to read, "If On Skin: Wash with plenty of soap and water. Get medical attention."

5. Due to the eye irritation, the product must be placed into child resistant packaging.

DIRECTIONS FOR USE ON LAWNS: For control of Dandelions, Chickweed, Plantains, Clover, and the other listed weeds, apply **WEED-B-GON® Lawn Weed Killer Formula T** any time weeds are actively growing. Weeds such as Wild Garlic and Wild Onions should be sprayed when they appear in late fall and again in early spring.

HOW TO USE: May be used with an **ORTHO** hose-end sprayer such as the **ORTHO Weed Killer Sprayer**, **ORTHO DIAL 'n Spray®** or **ORTHO SPRAY-ETTE®4**, or tank-type. Refer to table for recommended dilution. If lawn needs watering, water thoroughly the day before application. Do not water for 48 hours after application. Spray entire lawn, wetting weeds and lawn grasses; do not overspray. Spray when air is calm to avoid spray drift that might harm desirable ornamental plants. Do not apply if rainfall is expected, or if temperatures are expected to exceed 85°F within 24 hours following application. Make new dilution for each use. Seed can be safely sown 3 to 4 weeks after application.

Note: For best results, do not apply when grass is wet; spray weeds in the morning on a sunny day after the dew has dried. Do not exceed specified dosages. Do not apply to Dichondra, Lippia or Clover lawns. Temporary injury (slight yellowing which is usually removed in next mowing) may occur on sensitive lawn grasses like Centipede and St. Augustine. Do not spray roots of trees and ornamentals.

NEWLY SEEDED LAWNS may be treated after they have been mowed at least 3 times.

HARDY WEEDS: For hardy weeds such as Sheep Sorrel, Dock, Thistle, and Morning Glory in lawns and other areas, repeat application in 2 to 3 weeks if necessary.

Avoid spray contact or drift to susceptible plants as this product may injure flowers, shrubs, garden vegetables, fruit trees, and other crops. Coarse sprays are less likely to drift. When ORTHO Sprayer is used and washed thoroughly as directed on sprayer jar immediately after applying WEED-B-GON® Lawn Weed Killer Formula T, it can be used to apply insecticides, fungicides, and liquid fertilizers to ornamental plants.

For use with ORTHO DIAL 'n SPRAY®Hose-End Sprayer: (1) On Bluegrass, Fescue, and Ryegrass - Add 8 oz. product to jar (no water); set dial on sprayer to "4 tsp." Spray until jar is empty to cover 2,400 sq. ft. (2) On Bent, Bermuda, Centipede, Zoysia, and St. Augustine Lawns - Add 4 oz. product to jar and 4 oz. water; set dial on sprayer to "4 tsp." Spray until jar is empty to cover 2,400 sq. ft.

STORAGE AND DISPOSAL

STORAGE: Keep pesticide in original container. Do not put concentrate or dilute into food or drink containers. Avoid contamination of feed and foodstuffs. Do not store near feed, foodstuffs, fertilizers, seeds, insecticides, or fungicides. Store in a cool, dry place preferably in a locked storage area. Do not store diluted spray. Keep from freezing.

DISPOSAL: PRODUCT - Partially filled can may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash. CONTAINER - Do not reuse empty can.

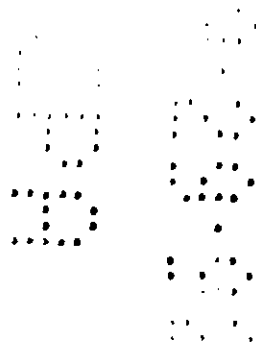
