

- (1) picture Pull sprayer from bottle
- (2) picture Pull green hose connector and coil from sprayer handle.
- (3) picture Insert hose connector into green spout on cap until it clicks into place.
- (4) picture Flip up spout, turn sprayer nozzle, and spray!

Roundup Ready-To-Use is pre-mixed and pre-measured. It will kill almost all annual and perennial weeds, grasses and other unwanted plants. Use on driveways and walkways, or around fences, trees, flower beds, shrubs and other areas in your yard. Roundup kills weeds by stopping the production of a substance found only in plants. Any Roundup not absorbed by the plant breaks down into natural materials. Roundup will not move in or on the soil to untreated plants.

### **CONTROLS ALL WEEDS AND GRASSES INCLUDING:**

Barnyardgrass, Bermudagrass, Thistle, Chickweed, Common Ragweed, Dandelion, Fescues, Johnsongrass, Clover and Yellow Nutgrass and many other annual and perennial grasses, weeds, sedges and brush.

### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in any manner inconsistent with its labeling.

### **WHEN TO USE**

Use anytime weeds and grasses are actively growing. Treated weeds usually show initial symptoms within 24 hours and complete kill in 1 to 2 weeks. Larger more established weeds may take up to 4 weeks for a complete kill. Roundup works best in warm sunny weather with daytime temperature above 60° F. Reapply if it rains within 6 hours after application. If hard-to-control weeds are not killed within 4 weeks, reapply.

### **HOW TO USE**

To treat individual weeds adjust the nozzle to a coarse spray. Spray when air is calm. Position sprayer tip approximately 1-2 feet from weeds and apply until completely covered. **IMPORTANT: Roundup is an all-purpose weed and grass killer which will kill almost all plants contacted.** If necessary, use cardboard or plastic to shield desirable plants. If plants are accidentally sprayed, rinse off immediately with water. Do **NOT** use for spot weed control in lawns since Roundup kills all green plants, including lawn grass.

Sprayed areas can be replanted with ornamentals or flowers the day after treatment.

**REUSE AND REFILL INSTRUCTIONS:**

[For use with the 24 fl oz]

To refill: Add 2 1/2 Tablespoons of Roundup Concentrate Weed & Grass Killer or 4 teaspoons of Roundup Super Concentrate Weed & Grass Killer to this empty 24 fl oz bottle. Then add 24 fl oz (3cups) clean tap water and use according to the label directions.

[For use with the 64 oz bottle]

To refill: Add 7 Tablespoons (3 1/2 fl oz) of Roundup Concentrate Weed & Grass Killer or 3 Tablespoons (1 1/2 fl oz) of Roundup Super Concentrate Weed & Grass Killer to this empty 64 fl oz bottle. Then add 64 fl oz (1/2 gal) clean tap water and use according to the label directions.

[For use with the 128 oz bottle]

To refill: Add 7/8 cup (7 fl oz) of Roundup Concentrate Weed & Grass Killer or 6 Tablespoons (3 fl oz) of Roundup Super Concentrate Weed & Grass Killer to this empty 128 fl oz bottle. Then add 128 fl oz (1 gal) clean tap water and use according to the label directions.

**STORAGE AND DISPOSAL**

[Larger Containers] **IMPORTANT:** After spraying flip spout down to close. Rotate nozzle to closed position. No need to disconnect. Snap sprayer back into place.

**STORAGE:** Store this product in its original container in a secure area. Protect container from freezing.

**DISPOSAL:**

To dispose of partially used or empty container, securely wrap it in several layers of newspaper and discard in trash.

In case of SPILL or LEAK, soak up with paper towels and discard in trash.
