DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

WHERE TO USE

Apply only where no weed growth is desired, such as driveways, brick walks, sidewalks, patios, parking areas, along paths, fences, curbs, and gutters; around buildings; and in decorative rock or bark landscapes; edging lawns; around the base of established trees, shrubs, and ornamental plants.

DO NOT use on or around fruits or vegetables.

FOR BEST RESULTS

1. Apply to actively growing weeds and grasses or bare ground.
2. Apply when daytime temperature is at least 60°F, when air is calm.
3. If leaves of desirable plants are accidentally contacted, immediately wash off plants with water. GroundClear has an all purpose weed killer which will kill almost all plants contacted.
4. Visible effects are yellowing or browning in 1 to 3 days with complete kill in 1 to 2 weeks.
5. Rain within 6 hours may reduce control of existing weeds, but will not reduce control of germinating seeds.

HOW IT WORKS

GroundClear™ has two-way action. One ingredient kills weeds by contact with foliage. The other ingredient puts an invisible barrier in the soil that prevents regrowth from sprouting grass seeds. Weeds begin to yellow or brown within 1 to 3 days with complete kill in 1 to 2 weeks.

HOW TO APPLY

Remove cap and tighten applicator head.
Turn over jug and apply by walking slowly, thoroughly covering all weeds/unwanted plants.
To adjust the spray pattern width, either raise or lower the jug.
For edging around trees, shrubs and buildings, lawns, fences and sidewalks, hold the jug about 2 to 6 inches from treatment area.
To use in larger areas such as walks and patios, hold jug at about waist height away from body to avoid contact with skin or clothing.
One gallon will cover a band 2 inches wide and 1200 feet long or 200 sq ft (10' x 20'). [24 oz container will treat 37 sq ft]
