Each fogger treats a room up to 5,000 cubic feet (25 ft x 25 ft x 8 ft ceiling). DO NOT use in a room 5 ft x 5 ft or smaller, instead, allow fog to enter from other rooms. DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables.

How to Prepare Area/Room

- Apply only when no food is being prepared.
