Your submission dated January 19, 2011

Dear Ms. Rothwell:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Replace “Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco” with “Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet” in the *Precautionary Statement* section.
2. Either delete cockroaches, palmetto bugs, water bug, scorpion and fleas from the list of *Non-Residual Claims / Optional Marketing Claims* or clarify that claims are for indoors only. See November 4, 2010 Efficacy Review.
3. Revise the following *Optional Marketing Claims* as follows:
  - a. Replace “Kills bugs inside. Keeps bugs out” with “Kills listed bugs inside. Keeps listed bugs out”.
  - b. Replace “Keeps ants, roaches [and spiders] away for up to 5 months indoors” with “Keeps listed ants, roaches [and spiders] away for up to 5 months indoors”
  - c. Replace “[One application] kills ants, roaches [and spiders] for up to 5 months indoors” with “[One application] kills listed ants, roaches [and spiders] for up to 5 months indoors”
  - d. Replace “Kills bugs inside, keeps bugs out for up to 5 months” with “Kills listed bugs inside, keeps listed bugs out for up to 5 months”

- e. Replace "Kills [bugs] in seconds" with "Kills [listed bugs] in seconds".
- f. Replace "Kills [bugs] fast" with "Kills [listed bugs] fast".
- g. Replace "Starts killing [bugs] in seconds" with "Starts killing [listed bugs] in seconds."
- h. Delete "Apply in other areas where insects [are often found] [often appear]"
- i. Delete "~~Gets into cracks and crevices~~"
- j. Delete "Gets to the places bugs hide"
- k. Delete "reaches where bugs hide"


