Dear Ms. Slack:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. Revise the Optional Marketing Claims as follows:
 - a. Replace "Kills bugs inside. Keeps bugs out" with "Kills listed bugs inside. Keeps listed bugs out".
 - b. Replace "Provides residual control against home invading insects" with "Provides residual control against listed home invading insects".
 - c. Replace "Use in [kitchens], [garages], [basements], [attics] to kill bugs [listed insects]" with "Use in [kitchens], [garages], [basements], [attics] to kill listed bugs [listed insects]".
 - d. Replace "Use in [kitchens], [garages], [basements], [attics] to keep bugs [listed insects] from entering your home" with "Use in [kitchens], [garages]. [basements]. [attics] to keep listed bugs [listed insects] from entering your home".
 - e. Replace "Kills [two] [2] ways [Dual Action]: 1) kills insects [by contact and 2) Keeps killing even after spray has dried" with "Kills [two] [2] ways [Dual Action]: 1) kills listed insects [by contact] and 2) Keeps killing even after spray has dried".
 - f. Replace "Protect(s) your home from bugs" with "Protect(s) your home from listed bugs"
 - g. Replace "Protect against [invading] bugs" with "Protect against listed [invading] bugs"

- h. Replace "Creates a barrier that [will kill] [kills] the bugs you have and help new bugs from coming [in] [inside your home]" with "Creates a barrier that [will kill] [kills] the listed bugs you have and help new listed bugs from coming [in] [inside your home]".
- i. Replace "Keeps ants, roaches [and spiders] away [out] for up to 3 months [indoors]" with "Keeps listed ants, roaches [and spiders] away [out] for up to 3 months [indoors]"
- j. Replace "Use in [kitchens], [garages], [basements] [and] [attics] to kill [bugs] [insects]" with "Use in [kitchens], [garages], [basements] [and] [attics] to kill [listed bugs] [listed insects]"
- k. Replace "Kills ants [and many other listed pests [listed insects]!]" with "Kills listed ants [and many other listed pests [listed insects]!]"
- 1. Replace "Kills ants [and] roaches [and many other listed pests [listed insects]!]" with "Kills listed ants [and] roaches [and many other listed pests [listed insects]!]"
- m. Replace "Kills ants, roaches [and] spiders [and many other listed pests [listed insect]!]" with "Kills listed ants, roaches [and] spiders [and many other listed pests [listed insect]!]"
- n. Delete "Barrier Technology [keeps bugs out [of your home]]"
- o. Delete "Barrier Technology keeps bugs from coming in"
- p. Delete "[Long-lasting] [5 month] Barrier technology"
- q. Delete "Spray around entire inside of your home to create a bug barrier"

ENVIRONMENTAL HAZARDS
