The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Delete the following claims, "Keeps bugs out all year!" and "Kills on contact" form the front panel.
2. Under *Other claims*, delete "Broad spectrum". This claim is overly broad and misleading or can give a false impression to the purchaser.

- Cover or remove exposed food (including pet food)
- Cover all food processing surfaces and utensils. Thoroughly wash with soap and water before re-use.

Create a bug barrier:

- Shake well before using.
- Hold can about 18" from surface being sprayed.
- Apply a 4" wide band in areas where insects are a recurring problem to create a barrier.
- Spray until surfaces are wet.
- **Indoors:** Apply along baseboards, beneath and behind appliances, sinks, cabinets, in pantries, on floor coverings (including carpet, tile, linoleum and wood floors), around plumbing and garbage cans, in cracks and crevices in walls, around window frames and doorways, and in attics and basements. 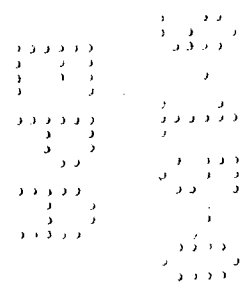

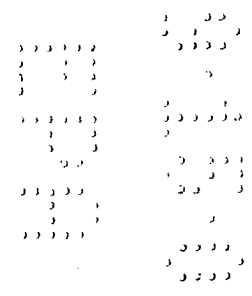
