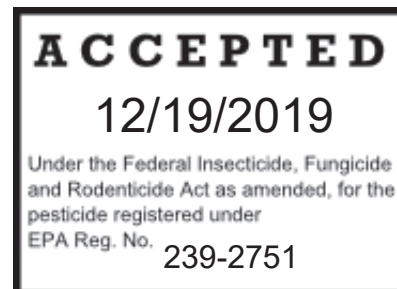

Direct spray to all parts of the room, especially at windows and other light sources that attract these insects. When spraying, keep nozzle in constant motion. Keep room closed for 15 minutes after spraying. Do not allow adults, children, or pets to enter until vapors, mists, and aerosols have dispersed, and the treated area has been thoroughly ventilated. Sweep up and discard fallen insects.

FLEAS AND TICKS: Before use, vacuum all infested areas thoroughly and dispose of vacuum bag in outside trash. Apply as a spot treatment to rugs, carpets, draperies and upholstered furniture.
