



RECOMMENDATIONS FOR USE

Consult your state agricultural experiment station or state agricultural extension service for additional information as the timing, number and rates of applications needed will vary with local conditions.

Care should be taken to avoid application on plums since foliage or fruit injury may result.

Apples: Apple Scab - Apply 25-40 lbs. of CYPREX 4% Dust per acre at 5 to 7-day intervals or as needed to maintain scab control from prebloom through first cover applications. Use 40 lbs. CYPREX 2% Dust per acre in later cover applications.

Do not apply within 5 days of harvest,

Dodine-TREATED APPLES SHOULD NOT BE USED IN THE MANUFACTURE OF APPLE POMACE FOR USE IN LIVESTOCK FEEDS. SUCH USE MAY RESULT IN ILLEGAL RESIDUES IN MILK OR MEAT.

Pears:

Pear Scab - Western States Only - Apply 25-40 lbs. of CYPREX 4% Dust per acre at 5 to 7-day intervals or as needed to maintain scab control from prebloom through first cover applications. Continue applications at 10 to 14-day intervals or as needed. Use 40 lbs. of CYPREX 2% Dust per acre in later cover applications.

Do not apply within 5 days of narvest.

DO NOT APPLY IN COMBINATION WITH LIME OR CHLOROBENZILATE.

Do not contaminate food or feed products.

Do not graze cover crops in treated orchards.
