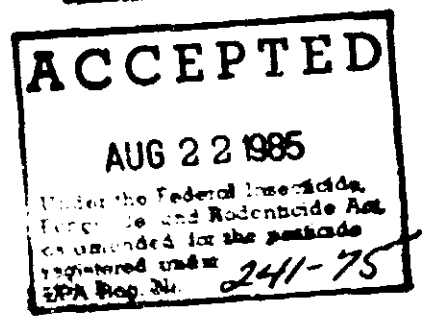

**STATEMENT OF PRACTICAL TREATMENT**

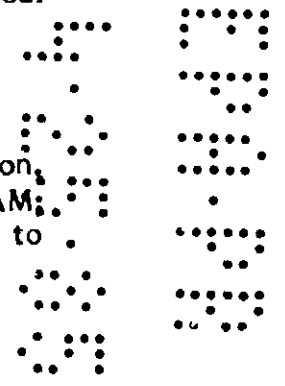

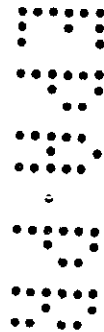

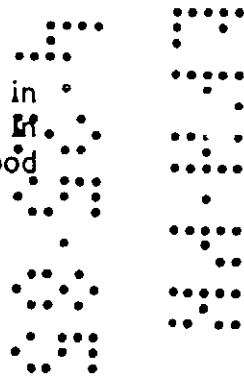
