Subject: Terbufos IRED Risk Mitigation Labeling Counter 15G Systemic Insecticide-Nematicide EPA Reg. No. 241-238 Label Received With Your Application of June 1, 2006

The labeling for the product referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, As Amended (FIFRA), is acceptable as a product registration amendment provided that you submit two copies of your final printed label for the product incorporating the following corrections before you release the product for shipment. Acceptance of the labeling does not constitute reregistration of the product.

1. Delete the phrase "in addition to the PPE listed above for loaders" which appears on page two in the PPE section for other handlers under the heading "IMPORTANT". This section includes a complete listing of the required PPE for other handlers.

2. Correct the designation "closed handling system" to "closed loading system" wherever the designation appears throughout the label. Please refer to item 16 in our previous letter dated April 20, 2006. The designation was corrected on the front page but still appears in other areas of the label.

3. Remove the phrase "same as crops above" which appears on page six in the directions for use on sorghum at bedding. The crop above is not the same crop.

4. Correct the warranty and disclaimer statements so that they are consistent with the Agency policy regarding such statements. The current Label Review Manual (guidance document on the OPP website at http://www.epa.gov/oppfead1/labeling/lrm/) incorporates these policy statements.

In general, OPP will not accept: (1) disclaimers that attempt to limit liability for what is expressly warranted by statements on the label; and (2) statements that ignore that the possibility of warranty enforcement under state or other applicable laws governing warranties. The State and local laws may not allow certain limitations of liability or remedy. Disclaimers that purport to limit liability for statements made or implied by the label are not acceptable (e.g., "this product may not work as intended" or "seller makes no warranty of results to be obtained by use of the product"). The attachment contains examples of problematic warranty statements. The problematic portions of the label statements are stricken, and necessary language is added in red.

The attachment shows the addition of the phrase, "to the extent consistent with applicable law" to the disclaimers of liability and damages to avoid the statements being false or misleading. Some states or localities may not allow certain disclaimers of liability or damages; therefore, the user/buyer may have a remedy under other law governing warranties.

The statement relating to using the product in accordance with its labeling is corrected on the attachment from "should" to "must". The phrase "should follow directions" could mislead users to believe that the directions for use are only suggestions and not enforceable restrictions on how the product may be used.

If this condition is not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product bearing the amended label constitutes acceptance of this condition.

A stamped copy of the label for the subject product is enclosed for your records.

The additional item cited below is required prior to any issuance of reregistration for the product.

The data compensation regulations and procedures must be met for all the generic data requirements for the subject product. They may be addressed by citing the supporting generic data in the IRED, Appendix B. Data received by the Agency in fulfillment of the data requirements designated as data gaps in the IRED must also be cited. Since the IRED has been issued for the active ingredient, the cite-all method of support may not be utilized for reregistration of the subject product. The data cited/provided with your subject reregistration application did address these requirements for certain of the generic data; i.e. product chemistry data and the generic acute toxicity data.

Any issuance of reregistration for the product must await completion of the cumulative risk assessment for the organophosphate pesticides.



#### NOTE TO PHYSICIANS

Warning signs and symptoms include weakness, muscle twitching, headache, tightness in chest, respiratory depression, blurred vision, miosis, hypersecretion, nausea, vomiting, diarrhea, and abdominal cramps. If poisoning is probable, treat the patient immediately. Clear airway and provide oxygen before administering atropine. Give atropine intravenously (IV), intramuscularly or through an alternative route such as an endotracheal tube. Depending on severity of poisoning, use 2 to 4 milligrams IV in adults (or 0.05 mg/kg in children under 12 years) every 10-15 minutes until fully atropinized as shown primarily by control of pulmonary secretions. Proceed concurrently with decontamination using proper protective gear; for example, chemical-resistant gloves rather than cotton or leather ones. Use soap (preferably, tincture of green soap) and water, or a dilute hypochlorite solution, for decontaminating skin. Maintain atropinization by repeated doses based on recurrence of symptoms. Twenty to thirty milligrams, or more, may be required during the first 24 hours, and preservative-free atropine preparation should be used if large doses are required. Generally, inducing emesis is not advisable. Avoid oplates, parasympathomimetic agents (e.g. succinvlcholine), theophylline, reservine, and or phenothiazines. Suction oral secretions and emesis to avoid aspiration. Artificial respiration or oxygen administration may be necessary. Probable mucosal damage may contraindicate the use of gastric lavage. If not contraindicated, gastric emptying by lavage may be considered after ingestion of a potentially life-threatening amount if it can be performed soon after ingestion (within an hour). A slurry of activated charcoal may be medically warranted at an oral dose appropriate for adult, child, or infant. For seizures, give a benzodiazepine intravenously. Observe patient continuously for at least 72 hours. Allow no further exposure until cholinesterase regeneration has taken place as determined by blood tests.

Pralidoxime chloride (2-PAM; PROTOPAM chloride) appears to be an effective adjunct to atropine, especially in those severely ill and if given soon. Before it's administered, obtain a blood sample for cholinesterase analysis. Adjusting for age and weight, pralidoxime may be administered as a continuous infusion after a loading dose or using a bolus method.

This label must be in the possession of the user at the time of pesticide application.

#### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), notification to workers, and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

**DO NOT** enter or allow worker entry into treated areas during the restricted entry interval (REI) of **48 hours**. The **48-hour** REI is increased to **72 hours** in outdoor areas where average rainfall is less than 25 inches a year.

- Maintain a 300 ft setback between the treated area and entry points to surface water bodies on highly erodible soils (HES).
- Maintain a 66 ft setback between treated area and standpipes on terraced fields as well as a 66 ft vegetative buffer between the tile outlet and entry points to surface water bodies.

All setbacks must be planted to a crop or seeded with grass or other suitable cover, and all vegetative buffers must be seeded with grass or other suitable cover.

**DO NOT** load, rinse or wash equipment within 300 ft from surface water bodies.

**DO NOT** load, rinse, or wash equipment within 50 ft from wells unless conducted on an impervious surface.

To prevent channeling of surface water runoff, adjust the planter row-cleaners appropriately to prevent rows lower in height than adjacent soil.
