For control of grass and broadleaf weeds, SQUADRON may be applied as a preplant incorporated or preemergence treatment.

DO NOT APPLY SQUADRON OR ITS TANK MIXTURES PREEMERGENCE IN SOUTH DAKOTA,,,;

After SQUADRON is applied, some susceptible weeks emerge, growth stops, and then the weeds either die or are not competitive with the crop.

Some dwarfing of soybean plants may occur with SQUADRON applications. This is the result of shortened plant internodes and has no effect on soybean yields.

There should be an interval of 90 days between the SQUADRON application and soybean harvest. DO NOT feed plants or straw to livestock.

Fill the spray tank one-half to three-quarters full with clean water. While agitating add the required amount of product and then fill the remainder of the tank with water. Maintain agitation while spraying to ensure a uniform spray mixture.

# SQUADRON plus PROWL® Tank Mixture For Heavy Grass Infestations in Soybeans

PROWL can be tank mixed with SQUADRON and applied preplant incorporated or preemergence if heavy or difficult to control infestations are anticipated from grasses listed in this leaflet.

On coarse textured soils add PROWL at 0.5 pint per acre and on medium and fine textured soil add PROWL at 0.5 to 1 pint per acre.

See the PRCWL label for soil types classified as coarse, medium and fine textured.

Apply this tank mixture preplant incorporated north of Interstate 80.

Observe all precautions and limitations on the PROWL LABEL.

## APPLICATION INSTRUCTIONS

## EARLY PREPLANT APPLICATIONS

SQUADRON may be applied up to 45 days prior to planting. Incorporate uniformly into the top 1 to 2 inches of soil within 7 days after application. See PREPLANT INCORPORATED APPLICATIONS section for incorporation instructions. Adequate moisture is required for activation of SQUADRON.

If soybeans are planted on beds, apply and incorporate after bed formation.

## PREPLANT INCORPORATED APPLICATIONS

Apply SQUADRON or its PROWL tank mixture before planting and incorporate uniformly into the top 1 to 2 inches of soil. Mechanical incorporation can be achieved by the following:

- (a) Field cultivator with 3 to 4 rows of sweeps (Do not use chisel points), spaced at intervals of 7 inches or less and staggered so that no soil is left unturned, set to cut 3 inches deep, and operated two times at more than 5 mph with the second pass made at an angle to the first.
- (b) PTO-driven equipment (tillers, cultivators, hoes) set to cut 2 inches deep and operated one time at 4 mph or less.
- (c) Rolling cultivator set to cut 2 to 3 inches deep and operated two times at 6 to 8 mph. Use only on coarse textured soils.
- (d) LELY-Roterra<sup>2</sup> set and operated according to the manufacturer's directions to thoroughly incorporate SQUADRON to a depth of 1 to 2 inches.
- (e) Do-All set and operated according to the manufacturer's directions to thoroughly incorporate SQUADRON to a depth of 1 to 2 inches.
- (f) Disk harrow set to cut 3 to 4 inches deep and operated in two different directions at 4 to 6 mph.

## PREEMERGENCE APPLICATIONS

#### MINIMUM AND CONVENTIONAL TILLAGE:

Apply SQUADRON or its PROWL tank mixture during or up to 2 days after planting. DO NOT apply postemergence to soybeans. As with other herbicides applied preemergence, rainfall or irrigation is necessary to activate SQUADRON in the soil. If sufficient moisture to activate SQUADRON is not received within 7 days after application, a thorough shallow tillage or cultivation is recommended (preferably with a rotary hoe) for optimum weed control.

#### NO-TILL SYSTEMS:

Apply SQUADRON or its PROWL tank mixture during or up to 2 days after planting. DO NOT apply postemergence to soybeans. If needed, apply paraquat or Roundup<sup>3</sup> in combination with SQUADRON. Refer to the respective labels for rates, methods of application, proper timing, weeds controlled, restrictions, and precautions. Use ground equipment only.

When SQUADRON is tank mixed with paraquat or Roundup, add SQUADRON to the tank first, next added PROWL (if used), then add paraquat or Roundup. When paraquat is included in a tank mixture, add 8 oz. of non-ionic surfactant per 100 gallons of spray mixture as the last ingredient in the tank.



- 2) A July 1 application cutoff date has been added on page 4 for the Northern Use Area.
- 3) APPLICATION INSTRUCTIONS (Preplant Incorporated Section) on page 8 deletes the note at the bottom regarding single pass incorporation.
- 4) ROTATIONAL CROP PESTRICTIONS section on page 7 now recommends "wheat" for fall planting after spring SQUADRON applications, instead of "small grains". Rotation to "barley" and "oats" is recommended eleven months after SQUADRON application. "Corn" has been changed to "Field corn". Rotation to corn or small grains the year after SQUADRON application is not recommended in the Northern Use Area, and recommended in the Southern Use Area only if a minimum of 15 inches of rainfall or irrigation is received from date of application through October. PURSUIT and PURSUIT PLUS have been added to the list of products rot recommended for application the same year as SQUADRON.
- 5) The western portions of Nebraska and Kansas have been deleted from the Use Area.
- 6) PURSUIT® and PURSUIT PLUS® have been added to the list of products not recommended for use the same year as SQUADRON.
