The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

## WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. The following specific comments pertain to your WPS labeling submission concerning the product cited above:

User Safety Recommendations must either be placed in a box or printed on the label in a contrasting color from surrounding text.

You have incorrect wording in the first paragraph in the Agricultural Use Requirements box on your proposed label. That paragraph must contain the exact wording of the paragraph shown as "2" in Section F on Part 2 of the Product Worksheet in Supplement Three-A to PR Notice 93-7.

You have incorrect wording in the second-to-last sentence in the first pararaph in the Agricultural Use Requirements box on your proposed label. The sentence must be as follows: "It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), notification to workers and restricted-entry interval." 9 10

## GENERAL INFORMATION

STOMP herbicide is recommended for preemergence control of grasses and certain broadleaf weed species as they germinate on noncropland areas, ornamentals, and established Christmas trees. STOMP treatments are most effective in controlling weeds when adequate rainfall is received within 30 days after application.

STOMP will not control established weeds. Therefore, areas to be treated should be free of established weeds at the time of treatment, or STOMP may be used in conjunction with herbicides registered for postemergence use in noncropland areas, ornamentals, and established Christmas trees. Consult the labels of those herbicides for suggested treatments, rates to be used and precautions or restrictions for use in noncropland areas.

### MIXING INSTRUCTIONS

- 1. Fill tank one-half to three-quarters full with clean water.
- 2. Add STOMP herbicide to the partially filled tank while agitating and then fill the remainder of the tank with water.
- 3. MAINTAIN CONTINUOUS AGITATION WHILE ADDING STOMP AND UNTIL SPRAYING IS COMPLETED. If the spray mixture is allowed to settle for any period of time, thorough agitation is essential to resuspend the mixture before spraying is resumed. Continue agitation while spraying.
- 4. If STOMP is to be used in tank mixtures with other registered herbicides, then follow directions on the labels of those products which recommend tank mixing.

## SPRAYING INSTRUCTIONS

Uniformly apply with properly calibrated ground equipment in sufficient water per acre to uniformly treat the area with a spray pressure of 25 to 50 psi. Maintain continuous agitation during spraying with good mechanical or bypass agitation.

## NONCROPLAND WEED CONTROL

STOMP is recommended for preemergence control of most annual grasses and certain broadleaf weeds as they germinate on noncropland areas such as railroad, utility and pipeline rights-of-way, highway guardrails, delineators, and sign posts, utility substations, petroleum tank farms, pumping installations, fence rows, storage areas, windbreaks, shelterbelts, and other similar areas.

For postemergence control of weeds, tank-mix combinations of STOMP plus ARSENAL<sup>®</sup> herbicide are recommended. DO NOT tank mix with ARSENAL in California. Recommended rates for the tank-mix compounds should be determined from the product labels of both STOMP and ARSENAL prior to use.

## WEED CONTROL IN AND AROUND ORNAMENTAL PLANTINGS

STOMP is recommended for use on the following established field grown and container ornamentals, plants & trees, and established ground covers. Care must be taken that soil or planting mixes have settled firmly following transplanting and that there are no cracks that would allow direct contact of STOMP and roots. Directed sprays where soil and media surfaces are uniformly covered will result in best weed control and ornamental tolerance. STOMP sprays can be safely applied over-the-top of those plants listed below.
